(b) In the event that the incurred level of effort exceeds by 5% or less of the task order requirement, but does not exceed the estimated cost of the task order, the Contractor shall be entitled to cost reimbursement for actual hours expended, not to exceed the ceiling cost. The Contractor shall not be paid fixed fee, however, on level of effort in excess of 100% without complying with subsection (d) below. This understanding does not supersede or change subsection (d) below, whereby the Contractor and Government may agree on a change to the task order level of effort with an equitable adjustment for both cost and fee.

(c) Either the "Limitation of Cost" or the "Limitation of Funds" clause, depending upon whether or not the task order is fully funded, applies independently and nothing in this clause amends the rights or responsibilities of the parties hereto under either of those two clauses. In addition, the notifications required by this clause are separate and distinct from any specified in either the "Limitation of Cost" or "Limitation of Funds" clause.

(d) The Contractor shall notify the Task Order Ordering Officer immediately in writing whenever it has reason to believe that:

(1) The level of effort the Contractor expects to incur under the task order in the next 60 days, when added to the level of effort previously expended in the performance of the task order, will exceed 75% of the level of effort established for the task order; or

(2) The level of effort required to perform the task order will be greater than the level of effort established for the task order.

As part of the notification, the Contractor shall provide the Task Order Ordering Officer a revised estimate of the level of effort required to perform the task order. As part of the notification, the Contractor also shall submit any proposal for adjustment to the estimated cost and fixed fee that it deems would be equitable if the Government were to increase the level of effort as proposed by the Contractor. However, whether an increase in fixed fee is appropriate shall depend on the circumstances involved, and, except as otherwise provided in the task order, shall be entirely within the discretion of the Contracting Officer. In no event, however, shall the fixed fee be increased unless the revised level of effort exceeds the previously established level of effort by more than 10%.

(e) In the event that less than 100% of the established level of effort, or if said level of effort has been previously revised upward, of the fee bearing portion of the additional hours by which the level of effort was last increased, is actually expended by the completion date of the task order, the Government shall have the option of;

## SECTION C DESCRIPTIONS AND SPECIFICATIONS

### STATEMENT OF WORK

#### 1.0 BACKGROUND

The Naval Undersea Warfare Center Division Newport (NUWC DIVNPT) is the Navy's engineering and technical support laboratory for research and development. The Sensors and Sonar Systems Department (Code 15) at NUWC DIVNPT is the principal agent for subsurface maritime sensors and sonar systems, research, analysis, development, integration, test, acquisition, and life-cycle support.

Within the 2005 Base Realignment Closure Committee (BRAC) Bill, approved by the President, NUWC DIVNPT is identified as a gaining activity. Subsurface sensor work at three locations (SPAWAR Systems Center San Diego, Naval Air Warfare Center Aircraft Division Patuxent River, and SPAWAR Charleston) is to be relocated to NUWC DIVNPT, Code 15.

#### 2.0 SCOPE:

The contractor shall provide engineering and administrative services relating to the BRAC 2005 transition to NUWC DIVNPT.

#### 3.0 APPLICABLE DOCUMENTS:

#### 4.0 REQUIREMENTS

The work to be performed falls within the scope of basic Seaport-E Statement of Work paragraphs 3.8, 3.9, 3.10, 3.11, 3.20, and 3.21.

##### 4.1 Analysis of Maritime Undersea Sensors and Sonar Systems Functions

The contractor shall analyze subject work being performed at the "losing sites" and shall identify the specific nature of this work, the sponsoring activity, and the funding profile. The contractor shall make recommendations as to how/where this work fits into the organizational structure at NUWC DIVNPT.

##### 4.1.1 Deliverables

The contractor shall deliver analysis and recommendations in accordance with CDRLs A001 and A002.

##### 4.2 Workspace Planning

The contractor shall investigate existing and new workspaces at NUWC DIVNPT for their adequacy (e.g. space, lighting, security, phone and computer hookups, building services, waste disposal) to receive equipment and personnel from the "losing sites". The contractor shall review plans and specifications of these workspaces. The contractor shall perform site visits to the "losing sites" to perform comparisons and to ensure compliance at NUWC DIVNPT and provide recommendations for required changes.

Analysis summary reports shall be delivered in accordance with CDRL A003. The contractor shall deliver issue papers/recommendations in accordance with CDRL A001.

#### 4.3 Site Support

The contractor shall evaluate plans, schedules, layouts (see GFI Section 6.0) and make recommendations to meet transition requirements.

##### 4.3.1 Deliverables

The contractor shall deliver issue summary reports and recommendations in accordance with CDRL A001.

#### 4.4 Equipment Handling, Reinstallation, Verification

The contractor shall provide support for the dismantling of equipment and preparation for shipping at the “losing sites” (for those "losing" sites which have their own team, the contractor will assist and analyze the requirements to perform the task so it can better reinstall the items at NUWCDIVNPT. For those "losing" sites which do not have their own team, the contractor may actually do the dismantling and make preparations for shipment, with actual shipment being done via that activity's transportation office). The contractor shall unpack the equipment; reinstall the equipment; and perform the checkout/verification of equipment operation at NUWCDIVNPT.

##### 4.4.1 Deliverables

The contractor shall deliver issue summary reports and recommendations in accordance with CDRL A001. Installation/checkout reports shall be delivered in accordance with A004.

#### 4.5 Integrated Product Team (IPT), Working Groups, Conferences

The contractor shall participate in BRAC community communication, collaboration and planning by participating in IPTs, Working Group Meetings, Conferences, Status Briefs, and Video Conferences. The contractor shall prepare updates to plans, prepare presentation material, and generate conference minutes for these forums.

##### 4.5.1 Deliverables

The contractor shall deliver status reports, recommendations, updates to plans, and presentation material in accordance with CDRLs A001 and A002. The contractor shall deliver conference minutes in accordance with CDRL A005.

#### 4.6 Interim Operational Support

The contractor shall provide concurrent support in accordance with the applicable documents in Section 3.0 to operations being transitioned during the phases of dismantling, movement and reinstallation of equipment such that operations may continue during the time of transition. This support shall be provided at the “losing site” and the “gaining site” (see para. 4.4 above for additional information).

## 7.0 QUALITY SURVEILLANCE & PERFORMANCE STANDARDS

The government will conduct quality surveillance via various methods including formal and informal meetings, review of technical reports, review of monthly progress reports, and review of deliverables.

Contractor performance will be evaluated in the areas of technical quality, responsiveness, timeliness and cost. Technical quality will be evaluated against the performance standards defined in applicable documents and GFI in Section 3.0.
